Program Overview

- Once enrolled in Virtual Academy, the student must stay enrolled until the end of the current quarter that they are enrolled in.
- Late work: all assignments past due will receive an automatic zero unless prior arrangements are made or dictated by a student IEP/504. The assignment will still be able to be completed after the due date. Any work completed after 3 days will not receive credit. No additional time will be given after the course end date.
- There is an expectation the student will participate synchronously with their teacher. All CP and Honors students will be required to complete Discussion Based Assessments for each module. All honor courses require proctored modules and semester exams. Other course assessments may be proctored per teacher discretion.
- Plagiarism will not be tolerated. Students will not receive any credit for any submissions in question.
- Virtual class grades will appear on report cards; however, this grade is reflective of the student's current progress in the course only. Full credit course grades will be averaged using Semester A and Semester B. The course final grade will go on the transcript/report card once the course is complete.
- All courses have a final end date which follows the district's 2022-2023 School Year Calendar. These courses cannot be extended past that date without prior approval. Seniors must have all course work and assessments completed by **May 28th, 2024**. There can be no exceptions and all assignments not turned in will be given a score of 0%.
